The Illinois Club Board Meeting Monday, January 30, 2012

- I. The meeting was called to order by President Sheila Krein at 7:15 pm at the home of Alma Bellafiore. Brief introductions of those present were made. - II. Secretary's Report Sheila Krein for Nancy Uchtmann, who is out of the country. Sheila asked for a volunteer to take the minutes. A motion was made to accept the minutes as corrected. The motion was approved.
- III. President's Report Sheila Krein and a few Board members will meet with Chancellor Wise for lunch on March 13.
- IV. Treasurer's Report Patricia Simpson presented the financial report see attached. She reported that an additional \$140 in membership fees or registrations was submitted since the report. The Holiday Party made \$120 for the Club. There has been over \$1800 in product sales since the beginning of the fiscal year!
- V. Position and Committee Reports
 - A. Programs Alma Bellafiore
 - 1. Alma has reserved the Hilton Garden Inn for the Sept. 10, 2012 Fall Expo
 - 2. Alma reported 58 people attended the Holiday Party on December 8 at Clark-Lindsey. A good time was had by all who attended.
 - 3. The Antiques Appraisal and Tea, scheduled for Sunday, February 12 at the Urbana Civic Center from 1 3 pm has only 22 people registered. This is too few to break even. We need at least twice that number. Alma proposed cancelling the event. It was suggested that she hold the event at her house. She agreed. We will make the food for the event. A signup sheet was passed around. Alma will cancel the Civic Center and reduce the hours with Matthew Peckham, the appraiser for the event.
 - 4. The Scholarship Awards Brunch will be held on March 3 at the Hawthorn Suites. Dr. Robert Easter will be the speaker.
 - 5. The Spring Luncheon will be held on May 3 at Biaggi's Ristorante Italiano. Dr. Kathleen Conlin will be the speaker.
 - B. Newcomers Mary Hosier.
 - 1. The Newcomers' event at the Kanfer studio held on November 22 went well.
 - 2. The story telling event called "*A Winter's Tale*" will be held on Wed., Feb. 29 in the home of Stephanie Price. Kim Sheahan from the Spurlock Museum will be the storyteller. There will be finger foods. Attendance will be capped at 20. Newcomers can RSVP by phone or email to Stephanie since there is no charge for the event.
 - 3. Newcomers will host a show at Parkland's Staerkel Planetarium on Thursday, March 29. The program will be "*Black Holes: The Other Side of Infinity*". Donna Cox will speak. All members and guests are welcome to attend. Newcomers and potential guests are free. Members and other guests pay \$5.

- C. Tours Julia Schmidt
 - 1. The stadium tour on Jan. 20th went well, with about 40 people visiting the stadium tour and 20 to Houlihan's.
 - 2. The Newells' Equinox House tour is planned for Friday, April 13 at 4:00 pm. The tour is free. An optional dinner or drinks will be at Montana Mike's Steakhouse in Urbana immediately following the tour. People will pay their own bill at the restaurant. This is a change since Kennedy's restaurant is now closed. Nine people are already signed up.
- D. Corresponding Secretary Pat Davis reported that she sent out 3 cards since the last meeting, including one to the Easters.
- E. Membership –Sharon Michalove made a directory addendum page with new and corrected contact information. It will be included as an insert in the mailed Feb. newsletters and attached as a PDF file to the email which announces the link to the Feb. newsletter online. This procedure is to protect the privacy of the members. A vote was needed to approve new member Stefani Janosco, who does not have a connection to the university. The vote was favorable.
- F. Newsletter Peri Ceperley reported that she is working on the Feb. newsletter and hopes to finish it by the end of the next week. The deadline is past, so attendees were encouraged to submit materials as soon as possible.
- G. Scholarships –Susan Haney reported that interviews are taking place, with 19 more on Tues. and Wed. this week. The Haney Scholarship winner has been chosen. Susan will work on a WebTools version of the application for next year. - H. Publicity For general publicity, Elisa Mustari asked about posting TIC flyers on department bulletin boards. Other ideas for publicity included doing a spot on TV, coverage in The News~Gazette, e-week (which she has done), contact someone at the Credit Union about ways to advertise the Club to employees, for example, leaving flyers on counters. Sarah Gertner asked if realtors still hand out our flyers. Elisa could start by contacting TIC member and realtor Sharon Harkness. Sheila read a report from Jane Heaton, Interest Group Publicity. Jane says she has been preparing the email news on a weekly basis, and people should continue to send her their submissions by 5 pm on Thursday.
- VI. Committee Reports
 - A. Big Ten Committee, 2013 Conference Susan Haney had nothing new to report.
 - B. Nominating Committee Carrol Finnigan-Bunick presented the current slate of proposed officers. She informed the board that only the elected positions will be voted on by the general membership at the Scholarship Awards Brunch.
