The minutes from the last board meeting were approved as distributed. Those present introduced themselves.

Board Reports

<u>President:</u> The meeting was conducted by outgoing President Peri Ceperley, who thanked the old board members for their service. Incoming President Sarah Wisseman requested that suggestions for luncheon speakers be given to her.

<u>Treasurer:</u> Linda Lopez said that the audit committee is appointed by the outgoing President, and the committee should meet as soon as possible after the fiscal year closes July 1. The budget chair is the outgoing treasurer, and Linda will check the bylaws for further information. She reported that the club's University account for campus expenses has not been closed for the year due to outstanding bills for the spring luncheon, and that the club absorbed some of the expenses for the newcomers' Amish dinner.

July 18 the newcomers will meet for a concert at the Research Park; August 8 at a concert at Allerton; September 4 from 5-7 at Kathy's house for a meet and greet wine and cheese.

<u>Tours:</u> Kathy Valdes will meet with Julia to discuss suitable dates. Some ideas being considered are a glass tour in Paris, a Clinton barn tour and a Chicago ethnic grocery tour. New ideas for events are welcome.

Corresponding Secretary: A thank you note was read from Mehri Cowan.

<u>Membership</u>: Sandy Camargo reported that 44 members have paid dues for 2014-15. Dues will be forwarded from the old year to the new for one member who had difficulties contacting an interest group.

Web Master: Mike Haney will need an assistant to work on updating the website.

Ideas for restructuring the job of Treasurer:

The treasurer must ask PayPal to send club receipts to the club's Busey Bank account. A PayPal administrator would be useful.
