Kathleen Conlin is an active member of the Society of Stage Directors and Choreographers, a professional union. Proposed Constitutional Amendments to be Voted on at Spring Luncheon

Position Title Changes & Composition of Governing Board Members Amendments

- 1. Position Title Changes in Article IV., Sections 1. A. & B.** – We propose to change the titles of some of the Governing Board positions. These new titles would better reflect the position duties and make other titles less cumbersome. There is not an implied progression with the vice president positions, except for the 1st Vice President to President, so there is no need to have the long titles of the 2nd and 3rd Vice Presidents and their Assistants. The Constitution lists Publicity Chairs as Board members without defining their titles. The differentiation between the two implied chairs has been in the newsletters for many years. The titles of the chaired positions would be listed alphabetically and be capitalized. In addition, the current Executive Committee positions would be spelled out in naming the Governing Board in **Article IV., Section 1. A.**, thereby not making the reader go to **Article VI., Section 1** to see who is on this committee. The proposed titles would change globally throughout the Constitution and Standing Rules. None of these is actually a change in substance to the Constitution or Standing Rules.
- 2. Article IV., Section 1. B.** – We feel the Scholarship Chair and the Assistant Scholarship Chair should be the only members of the Scholarship Committee on the Governing Board. Currently the entire Scholarship Committee is on the Board. Members of other committees do not serve on the Board, unless they already hold a position on it, e.g., Treasurer on the Finance Committee. We propose to strike the phrase "...and scholarship committee members" in **Article IV., Section 1. B.**

1. Title Changes Amendment

The titles of the following Board positions will be changed globally throughout the Constitution and Standing Rules, with the titles of all positions listed here and in the aforementioned documents being capitalized and with the chaired positions listed alphabetically:

2. Composition and Listing of Governing Board Members Amendment

Current Text:

ARTICLE IV. GOVERNING BOARD

Section 1. ELECTED MEMBERS, APPOINTED MEMBERS, SUSTAINING MEMBERS

- A. The elected members shall be the executive committee (Article VI Section 1) and the assistant second vice president, assistant third vice president, assistant treasurer, membership/directory chair and assistant chair, newsletter chair and assistant chair, scholarship chair and assistant chair, publicity chairs, meeting manager, and budget chair.
- B. The appointed members shall be the archivist, tour director, hospitality chair, web master, and scholarship committee members. These members are appointed by the president.
- C. The sustaining member shall be the immediate past president of the Club.

**Proposed new wording, using current titles for clarity,
but which would change if the Title Changes Amendment passes:**

ARTICLE IV. GOVERNING BOARD

Section 1. ELECTED MEMBERS, APPOINTED MEMBERS, SUSTAINING MEMBERS

- A. The elected members shall be the president; first vice president (programs); second vice president (newcomers); third vice president (interest groups); recording secretary; treasurer; corresponding secretary; meeting manager; chairs of budget, membership/directory, newsletter, publicity, and scholarship; assistant second vice president; assistant third vice president; assistant treasurer; and assistant chairs of membership/directory, newsletter, and scholarship.
- B. The appointed members shall be the archivist, tour director, hospitality chair, and web master. These members shall be appointed by the president.
- C. The sustaining member shall be the past president of the Club.

3. Executive Committee Composition Amendment

Article VI., Section 1. – We also propose to redefine the Executive Committee to make it a smaller working committee. We would add the Past President, a member with longer Club history, and remove the Corresponding Secretary and the 2nd and 3rd Vice Presidents. Other chairs are not on the Executive Committee, so with the position title changes, it's harder to justify the inclusion of the Newcomers Chair and Interest Groups Chair. The Corresponding Secretary, who sends cards to members, has an even less involved role in overall Club business. An odd number is desirable to break any ties. This size and composition is more in keeping with other organizations.

Current Text:

ARTICLE VI. COMMITTEES

Section 1. THE EXECUTIVE COMMITTEE

This committee shall consist of the president, the first vice president (programs), the second vice president (newcomers), the third vice president (interest groups), the recording secretary, the corresponding secretary, and the treasurer.

**Proposed wording, using current titles for clarity,
but which would change if the Title Changes Amendment passes:**

ARTICLE VI. COMMITTEES

Section 1. THE EXECUTIVE COMMITTEE

This committee shall consist of the president, first vice president (programs), recording secretary, treasurer, and past president.

On this early spring-like day we debuted our current scholarship award winners at our annual brunch. A delicious feast, Ikenberry winner Ben Montalbano's music compositions, and excellent remarks from our soon-to-be-President, Dr. Robert Easter, were the order of the day. His insightful words hit the mark, as he warmed up the crowd for our amazing winners. Afterwards the Easters chatted with members and winners as everyone lingered. Although some award winners were absent, their speeches effectively conveyed why we chose them.

Judith Life Ikenberry Fine Arts Award

Benjamin Montalbano hails from a small town, Dwight, but has big dreams for his Music Composition major. From a non-musical family, his family recognized his gift early on and encouraged him. He became his church's youth choir director and organist at twelve, and grew from there. He's the stage manager for Sinfonia da Camera, the Canopy Club's piano man, and gets commissioned to write music. A future classical music star!

Susan T. Haney Social Work Award

What can we say about **Emily Landeck**, except "Wow!!!" This ball of fire holds three jobs to put herself through school (On Call Youth Advocate case assistant, personal assistant for a disabled student, nanny) that comprise up to 60 hours of her week on top of her full load of Social Work classes. Emily has also studied abroad in Costa Rica to learn what it was like to be a minority, which has inspired her to learn Spanish. This award means that she can work less and volunteer more. She's at the top of her class, in every way.

The Illinois Club Make-A-Difference Awards

Another hard worker putting herself through school is **Laurie DeHaan**, a Civil Engineering major. She wants to be a project manager for a large construction company building sustainable health care facilities. Her work with Engineers Without Borders resulted in a trip to Cameroon to educate villagers about hygiene in preparation for installing a clean water system that she helped to research and design. She'd love to be in the Peace Corps.

Jonathan Fast is combining his two majors of Biology and Painting into medical illustrating. His many interests include fashion design so he's worked as a freelance seamstress and patternmaker to help produce collections for Fashion Week and general mock-ups. He's donated his collections to Sisters on the Runway, as well as worked with Surfing 4 Peace to help design a burkini for Muslim women in Gaza who surf.

Studying abroad this semester in Spain, **Jordan Hughes** hopes to use her Community Health major after law school to advocate for health care reform; to lobby for new laws supporting those with disabilities; and to work with others to use the law to help those who need it most. Through her earnest philanthropic efforts on campus she helped raise more than \$30,000 for Make-A-Wish. She's also a talented writer for *Buzz* on campus.

After taking time off after high school, **Bryan Plummer** reignited his passion for science and worked for AmeriCorps at the Arizona Science Center to design displays and games to interest children in science. He also volunteered in the Center's Outreach and 21st Century programs, working with children to create Science, Technology, Engineering, and Math (STEM) Clubs. His internship at the UMBC/NASA Goddard Space Flight Center resulted in a job offer, but he's pursuing a PhD in Computer Science in the area of robotics first.

An Indian immigrant, **Akshita Siddula** was inspired by her grandfather's medical work among poor villagers as well as her own family's struggles with health care here to enter the medical field or Public Health (Non-profit Management). She hopes to work abroad as a medical professional and educator. Her work with Expanding Lives helps empower women in western Africa through education and quality, affordable healthcare access.

Kari Wozniak is also paying for her own education. This incredible young woman has studied abroad in South Africa, Ecuador (the only white person within 100 miles), and India to bring scope to her Global Studies major and Spanish minor. Her dual concentrations in Wealth and Poverty and Global Food Systems reflect her dreams of graduate studies in international relations and economics. She'd love to work with the UN Food and Agriculture Organization, and is getting a jump start as a summer intern at the US Department of State.

Isabelle Purnell Education Awards

Andi Bonner knew from a young age that she wanted to teach. Miss Andi's classroom then was full of dolls, stuffed animals, and her stepdad. Now she loves the students who struggle and need extra support and guidance. Her three watchwords - calm, clear, and creative - guide her in all that she does for her students. This Elementary Education major's effervescent personality and love of teaching are bound to serve her well.

Another passionate teacher, **Jessica Michnowski** believes in the power of education in fighting the cycle of poverty. With her experiences in South Africa and Zambia as an inspiration, she plans to use her Elementary Education degree to become an English teacher in Africa. A cheerleader for seven years, she uses the lessons learned there about the value of unity, friendship, trust, encouragement and responsibility in her classroom.

An English major, **Jeanne Zeller** also studied abroad in Costa Rica to experience being a minority, even taking a class in Spanish. At the semester's end she volunteered full time at an organization that works with victims of human trafficking. Her volunteerism in difficult areas began during high school in response to the large number of suicides in her school. She helped found an initiative, HOPE, for the prevention of depression and suicide. Jeanne's diverse experiences will help her connect with her students and empower their voices to be heard.
