Proposed Constitutional Amendments

Amendment Results

from the Scholarship Awards Brunch

The amendment to Article IV (Governing Board), Section 2.C (Term) was passed at the Scholarship Brunch. The quorum standard of 20 votes was met, and a total of 36 members cast their ballots. 31 voted in favor of the amendment. Susan Haney is now eligible to serve, and will serve, for another year. In addition, others can continue to serve on the Board for more years.

New Proposed Amendments

The Board makes the following recommendations:

Quorums: The Board proposes changing how many Governing Board members are required for a quorum. Because of work commitments, Board Members often have difficulty attending meetings. The proposed amendment will enable TIC to continue to recruit the best qualified board members, yet have the ability to make decisions at Board meetings. Those Board Members that cannot attend have the opportunity to read the meeting minutes and ask questions/comment.

Composition of the Scholarship Committee: Because we now receive over 75 applications each year, we need to add more members to the Scholarship Committee to read applications, conduct interviews, and publicize scholarship winners. The Board also wants to emphasize that scholarship committee members are part of the Governing Board.

Composition of the Program Committee: The Constitution currently lists the Program Committee as only the first vice president and the meeting manager. The Hospitality Chair (HC) is not listed, although he/she is one of the most vital parts of putting on our programs. Reservations go to the HC. After a program is set, the HC keeps track of all the information that forms the basis for subsequent decisions. The HC transfers collected payments to the Treasurer. The Board therefore recommends that the Hospitality Chair be part of the Program Committee.

Dues Delinquency: The proposed amendment moves up the date when dues are regarded as delinquent. Currently dues are delinquent on December 1. By moving the date to October 1, the Board is better able to base budget decisions on real, versus projected, budget information. In addition, the Directory editors will be able to publish the Directory in the Fall.

Text of the Proposed Amendments

ARTICLE V. MEETINGS

Section 2. QUORUM

The members in attendance at a meeting shall constitute a quorum provided that the number in attendance is not less than five percent of the membership. A quorum at a board meeting is one third of all Governing Board members.

ARTICLE VI. COMMITTEES

Section 6. SCHOLARSHIP COMMITTEE

This committee shall consist of the scholarship chair, assistant chair, and as many others as is deemed necessary, to be appointed by the president. The president of the Club may be a member of this committee. It shall review all applications and select recipients. It shall submit award winner information to all relevant colleges and departments for publication or publicity.

Section 8. PROGRAM COMMITTEE

This committee shall consist of the first vice president, the meeting manager, and hospitality. It shall arrange the programs and the locations of the meetings for the Club year, and all necessary activities for the meetings.

ARTICLE X. DUES

The Governing Board shall determine the amount of the annual dues. Dues are pay-able as of the fall meeting and delinquent as of October 1st. Members are welcome throughout the year; however, dues are not prorated.

Microbial Life on Planet Earth: Coral Reefs, Hot Springs, Meteors and Aqueducts

Bruce W. Fouke, Ph.D.
Associate Professor
in Geology, Microbiology, and the
Institute for Genomic Biology

Professor Fouke studies complex interactions between planet Earth and the many forms of life that inhabit it. His ongoing work includes analyses of: (1) the bacteriology of coral disease; (2) microbe-mineral interactions in hot springs; (3) the last flow of water in Roman aqueducts; and, (4) meteor cratering associated with the demise of the dinosaurs. Professor Fouke received his Ph.D. from the State University of New York, Stony Brook, and completed postdoctoral research appointments at the Free University of Amsterdam, the University of California Berkeley, and NASA Ames Research Center prior to arriving at Illinois. His work has been highlighted in National Geographic Magazine as well as on National Public Radio. He currently serves on science panels at the National Science Foundation and NASA.

Samantha Blum, Bioengineering

Samantha chose a career in medicine her mother's battle for ten years with ovarian cancer, which claimed her life last fall. Samantha has been actively involved in cancer awareness and fundraising campaigns, becoming one of the top fundraising students on campus. She dreams of becoming an oncologist searching for cancer cures. Samantha also spoke movingly of her mother's fortitude, grace, and optimism under difficult circumstances, impressing and inspiring us all with her composure. For her, this award was the best thing that had happened to her in a long time. It was apparent to all that her mother's grace and dignity lives on.

Rachel Day, Molecular and Cellular Biology

Rachel wants to pursue a career in medicine. Her mother was diagnosed with cancer several years ago as well, but is a healthy survivor. It was Rachel's experiences with her mother's hospitalizations that first inspired her to choose medicine. Of course, it didn't hurt that her mother is also a nurse. Her lighthearted and funny presentation captured her enthusiasm for all things medical-no matter how squeamish!-perfectly. She hopes to work in rural areas and teach patients how to stay healthy.

Craig Podalak II, Architectural Studies

Craig hopes to integrate into his designs elements that will assist those who are challenged either by age or a handicap. He spoke of his efforts to provide accessible reading materials and library space to three senior citizen facilities in his community, securing close to 7,000 books (including Braille literature), tapes, and puzzles for this project. Craig was most influenced by his grandparents, who, as they aged, became physically challenged and needed a lot of care at home. His desire to make all buildings and public areas more accessible to everyone is inspirational. Craig turned down full scholarships to many schools so that he could study architecture here.
